PARK AND RECREATION ADVISORY BOARD AUGUST 15TH, 2018 REPORT

RE: Park and Recreation Board August 15th, 2018

1. Dog Park Update

Public Works staff has put in the culvert and parking lot, taken down the old fence. Fence company is scheduled to put up new fence starting August 13th, so we are still on schedule to have the grand opening end of September or beginning of October.

2. Recreation and Park Report

Majority of youth recreation programs were completed for the 2018 spring/summer season. Weather caused a few cancelled dates due to rain or cold, but overall season was good. 2513 participants for the 165 classes. Adult programs will continue to the end of August. Revenue for the youth programs \$81,000 and Parks revenue so far this year is 27,000 estimated by end of year \$32,000. Camping sites still mainly full with September and October months expected to be mostly full also

3. 2019/2020 Budget

City is in the process of completing the 2019/2020 budget.
