### 1) Approval of Police & Fire Commission Rules of Procedure

- A. Chief Young indicated would like to add the language to the Rules of Procedure Article 4.12.b. related to granting advanced standing to the oral interview phase to our reserve officers who meet the qualifications and requirements of the position. This is a process that has been done in the past and current Reserve Officers were advised when they were hired that advanced standing would be granted if they applied to an open patrol position within the Department.
