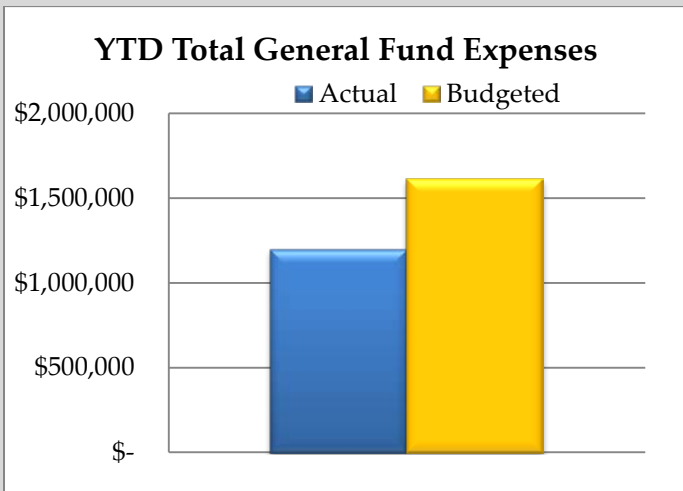

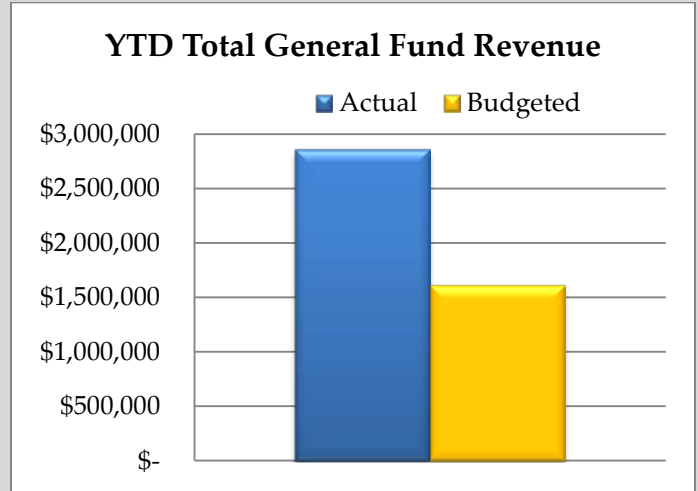
YTD Expenses

The actual, year-to-date total expenses of the General Fund compared to the budgeted year-to-date expenses.



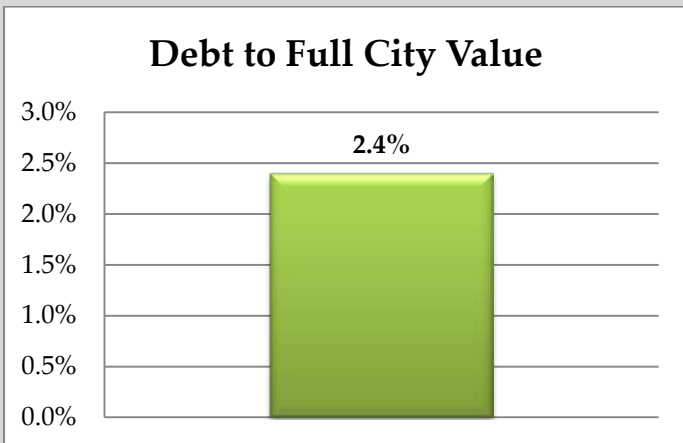
YTD Revenue

The actual, year-to-date total revenue of the General Fund compared to the budgeted year-to-date revenue.



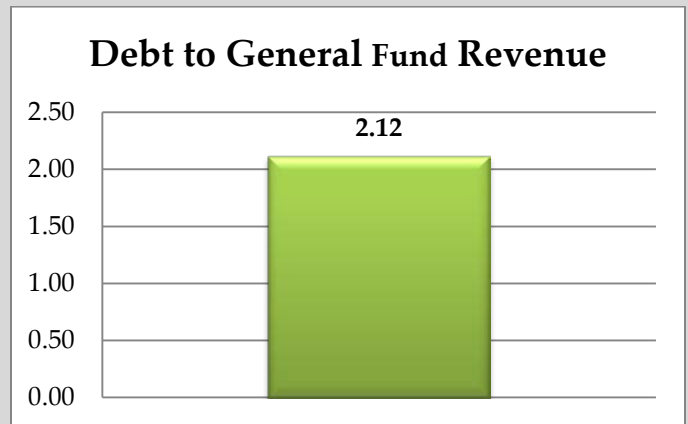
Debt to Full Value

The graph shows the ratio of general obligation debt to General Fund revenue.

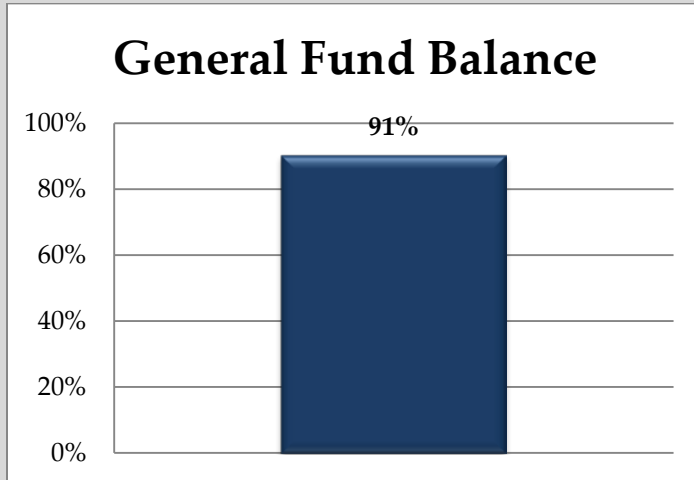

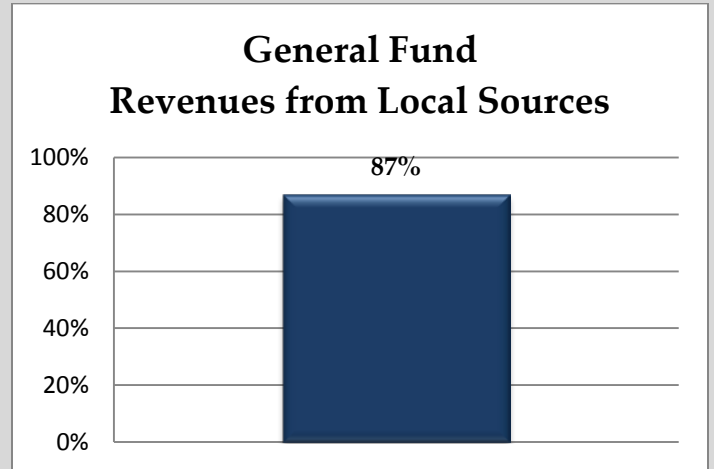
General Fund Balance

Operating Ratio

This is Operations and Maintenance Expenses, excluding Depreciation and Interest, divided by Total Operating Revenues.

The Target is < 75%.

This ratio describes the fund's ability to generate profit, i.e. percent of expenses used to generate \$100 in operating revenues.

Net Take Down Ratio

This is Operating Income divided by/Gross Revenues.

The Target is > 40%.

This ratio describes the fund's profit percentage as compared to total revenues.

Debt Ratio

This is Fund Liabilities divided by Fund Assets.

The Target is < 35%.

This ratio describes the fund's ability to meet debt and other liabilities, i.e. percent of assets used to pay off all liabilities.
